

## **TERMS AND CONDITIONS**

### **Permission/Waiver**

**Paradise Bound Ministries, Inc. ("PBM") is a religious non-profit corporation that relies on volunteer participants to fulfill its mission. Volunteer participants provide services on behalf of PBM in the United States and in foreign countries. If the volunteer participant is a minor, this form must be electronically signed and agreed upon by their parent or guardian.**

**I acknowledge that participation in the above trip involves risk to the Volunteer Participant (and to Participant's parents or guardians, if Participant is a minor), and may result in various types of injury while performing volunteer services including but not limited to the following: sickness, bodily injury, death, emotional injury, personal injury, property damage and financial damage. In consideration for the opportunity to participate in the trip, the undersigned volunteer (or parent/guardian) hereby acknowledges and accepts the risks of injury associated with participation in the trip. The Participant (or parent/guardian) accepts personal financial responsibility for any injury sustained during the trip. Further, the Participant (or parent/guardian) promises to indemnify, defend, and hold harmless PBM and its agents, employees, volunteers, or any other representatives (collectively included hereinafter in the term "PBM") for any injury related directly or indirectly out of the above trip, whether such injury arises out of the negligence of PBM or otherwise. If a dispute over this agreement or any claim for damages arises, the Volunteer Participant (or parent/guardian) agrees to resolve the matter through a mutually acceptable alternative dispute resolution process. The volunteer participant releases PBM and its officers, directors, other volunteers and agents from all claims that relate in any way to the performance of volunteer services. The undersigned volunteer (or parent/guardian) is fully responsible for all monetary loss suffered by the undersigned as a result of the volunteer services, including, but not limited to, medical expenses incurred in diagnosing and treating any injury or illness.**

**In the event of an injury or illness while performing volunteer services, and if the volunteer is unable to make his or her own decision regarding medical care, the undersigned volunteer participant (or parent/guardian) hereby authorizes PBM and its staff members to arrange for and consent to recommended medical treatment. The undersigned volunteer is fully responsible for the cost of any such treatment.**

**By attending the trip you grant permission for PBM to utilize your image, likeness, actions and statements in any live or recorded audio, video, or photographic display or other transmission, exhibition, publication, or reproduction made of or during the trip regardless of whether the above said were recorded before, during or after the trip, and you give permission without further authorization or compensation including its use in social media applications.**

Nor is PBM responsible for weather, or unforeseen conditions in a developing country.
